The Government of United Republic of Tanzania has set aside funds towards the cost of the **Supply of Medicines and Medical Supplies** and it intends to apply part of the proceeds of this fund to payments under the frame contract for **Supply of Medicines and Medical Supplies for Public Health Facilities**.

has intended to pre-qualify Applicants for **Medical Supplies for Public Health Facilities in Mainland Tanzania**. It is expected that invitations to tender will be made in **June 2018**.

4. Pre-qualification will be conducted through the procedures specified in Regulation 119 of the Public Procurement (Regulations- Government Notice 446 of 2013 and is open to all Applicants as defined in the Regulations.

5. Interested applicants may obtain further information from and inspect the pre-qualification documents at the Regional Administration Offices countrywide **except the Regions of Morogoro, Dodoma and Shinyanga** from 8:30 am to 3:30 Pm local time on Mondays to Fridays inclusive except on public holidays.
6. A complete set of pre-qualification documents in English may be purchased by interested Applicants on the submission of a written application to the address given under paragraph 4 above and upon payment of a non-refundable fee of **Tshs 150,000.00**. Payment should either be by Cash or Banker's Cheque, payable to Regional Administration Secretary.

All applications one original plus three (3) copies and one (1) electrical copy properly filled in and enclosed in plain envelopes must be delivered to the respective Secretary, Regional Tender Board at or before **10:00 am local time date 10<sup>th</sup> May 2018**. Applications will be opened promptly thereafter in public and in the presence of Applicants' representatives who choose to attend in the opening at the Regional Administration Secretary's Office in respective Regions.
8. Late applications, portion of applications, electronic applications, applications not received, applications not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
